On 6 February 2018, in accordance with Delegation 5 of the Head of Strategic Housing and Planning Service's Sub Delegation Scheme, the Head of Strategic Housing and Planning Services has approved the draft Brighton Road Conservation Area Statement for a four week publication period beginning 12 February 2018 finishing on 12 March 2018. The decision was taken following consultation with the Cabinet Member for Planning and Economic Development.

On 29 November 2017, Cabinet granted delegated authority to the Head of People and Technology in consultation with the Cabinet Member for Resources to approve the award of the contract following the tender award process.	
Subsequently, on 19 February 2018 the Head of People and Technology, in consultation with the Cabinet Member for Resources awarded a contract to Bidder 3 for the provision of a managed print service after a collaborative procurement with Horsham District Council and Mid Sussex District Council. The current contract for the supply and maintenance of Multi-Functional Devices (MFDs) expired in 2015 and has been extended on a temporary basis since that time. The fleet is operated under a lease basis.
