# **Play Facilities – Investment Proposals**

Report of the Director of Community Services CTY/100

## 1. Purpose

1.1 This paper sets out proposals for the future provision of unsupervised and supervised play facilities in Crawley for the period 2014/15-2018/19.

#### 2. Recommendations

#### 2.1 To the Overview and Scrutiny Commission:

That the Commission consider the report and decide what comments, if any, it wishes to submit to the Cabinet.

#### 2.2 To the Cabinet

- 1. Approve the proposed capital programme for children's play facilities over the period 2014/15 2016/17 for the schemes as set out in section 7 and Appendix 1 of this report.
- 2. Request a supplementary capital estimate to the value of £92,700 to be funded from Section 106 to cover the increase in budget requirement of £785,000 above the existing budget provision of £692,300.
- 3. Note the capital schemes proposed as priorities for the period 2017/18 and 2018/19 will be subject to future capital bids as part of the budget strategy.
- 4. Note the proposed priorities and purposes of the town's four adventure playgrounds and the children's play outreach programme.

# 3. Reasons for the Recommendations

3.1 The recommendations are made to agree priorities for investment in children's play facilities' and to confirm budget allocations against those priorities for the period 2014/15 – 2016/17.

## 4. Background

- 4.1 Over the last 5 years, the Council has invested in new and improved play facilities across the town with the focus being on the larger (type C and type B) facilities, ensuring these are accessible and of a high standard. Typically, such facilities offer a higher play value, retain interest for children as they grow and enable young and older siblings to play at the same location. Notably, this investment has taken place in Tilgate, Maidenbower, Bewbush, Broadfield, Ifield and Northgate. This investment has been well received and these facilities continue to be popular and well used.
- 4.2 There are three categories of facilities:
  - Type A' Facilities: Doorstep spaces within sight of home where children (especially young children) can play within view of known adults.
  - 'Type 'B Facilities: A larger space which can be reached safely by children beginning to travel independently and with friends
  - Type C Facilities (including adventure playgrounds): A larger space or facility for informal recreation which children and young people, used to travelling longer distances independently, can get to safely and spend time in play and informal recreation with their peers and have a wider range of play experiences.
- 4.3 Alongside the investment in unsupervised play facilities, the Council has extended use of the Adventure Playgrounds with the introduction of 'Playcare' (holiday play scheme providing supervised childcare) as well as a number of third party hire arrangements with other providers delivering children and youth activities.
- 4.4 The distinctive design of individual neighbourhoods across the town is reflected in different approaches to the provision for play. Despite this it is proposed that consideration for future investment is based on the following principles:
  - 1. At least one accessible and high quality larger (type C) facility serving each neighbourhood within the town
  - 2. A balance of more local Type A and Type B facilities which ensure that overall the local space standard for children's play (0.05ha per 1000 people) is met (or where this is not possible, there is a good geographic spread of facilities and all of the facilities are rated as satisfactory or better).
  - 3. he Adventure Playgrounds serve as community settings for a variety of young people's activities (these activities being delivered directly by the Borough Council and / or in conjunction with other voluntary sector / other statutory agencies).
  - 4. Design of any new or improved facilities will be in consultation with local residents and in particular young people in the local catchment.
  - 5. With regard to the design of specific play facilities, the design principles of Design for Play (Play England) are adopted.
  - 6. Through the Outreach Programme, the Council will work in areas not served as well by the built play facilities and will work with residents to develop their own opportunities to promote children's play within their neighbourhoods.
- 4.5 In 2013, the Council rationalised the number of strategies it formally adopts with the focus being on those only required statutorily. Although it is not a statutory requirement to formally adopt a Play Strategy, these recommendations are brought forward to Cabinet given the proposed capital allocations over the next five years.

# 5 Description of Issue to be resolved

5.1 There is a need for a clear rationale to agree priorities for future investment in play. The process for determining priorities has been thorough and provides a sound rationale.

## 6 Information & Analysis Supporting Recommendation

- 6.1 In considering recommendations for future provision of children's play facilities, the analysis and recommendations are developed on a neighbourhood basis utilising the following data sources:
  - 1. Crawley Open Space, Sport and Recreation Study
  - 2. Demographic and 'Mosaic' population group data
  - 3. Play Value Assessments of existing play facilities
  - 4. Usage analysis of existing facilities
  - 5. Community consultation and views from residents and service users.
- 6.2 The recommendations for investment are divided into two categories:
  - **Short /Medium Term:** These proposals are costed and budget provision is available within the existing capital programme for play covering the period 2014/15 2016/17.
  - Longer Term: Provisional budget requirements are indicated. There is not currently budget provision to meet these proposals and delivery of these would be subject to capital programme allocations within the period 2017/18 2018/19.

#### 6.3 Unsupervised Playgrounds

Utilising the analysis set out in paragraph 6.1, the recommendations for each neighbourhood are presented in Appendix 1 to this report with the budget allocations summarised in section 7.

#### 6.4 Adventure Playgrounds

The Council manages four adventure playgrounds across the town. The operating hours of these facilities have been revised in recent years to reflect the core times when local children seek to access these. The review of operating hours and continued attention to promoting a varied play programme has helped maintain good levels of attendance at the open access sessions with over 15,000 visits to the sites over the school summer holidays in 2013.

- 6.5 Consultation with adventure playground users (parents and children) as well as children across the town more generally has recently been undertaken and the following are proposed as priorities for the future provision and management of the Adventure Playgrounds:
  - 1. Provide a free and open access high quality play programme from the Adventure Playgrounds at times when there is evidence of strong demand from residents
  - 2. Promote the availability of the adventure playgrounds to voluntary sector and other statutory sector organisations to deliver children's / youth activities from the sites
  - 3. Promote the availability of the adventure playgrounds for children's parties and other hiring activities
  - 4. Utilise the adventure playgrounds to provide a dedicated school holiday childcare facility for working parents
  - 5. Seek to 'open up' the outdoor facilities at the adventure playgrounds to facilitate their use at times' when they are not staffed or providing structured programmes.

#### 6.6 **Outreach Direct Delivery**

The Outreach Play workers deliver innovative play programmes in key locations, typically where a neighbourhood is not served by an adventure playground. As well as encouraging the development of playful environments in the immediate locality, participants and their families are encouraged to use their nearest adventure playground and access the full

range of services. The Play workers will also link with primary schools to encourage greater use of the playgrounds as an outdoor classroom environment and in doing so exposing children and their families to the wider play service offer.

## 6.7 Play Training Programme

The Council's Play Outreach workers are experienced in setting up and delivering creative, imaginative and developmental play programmes. As a new initiative, the Play Training Programme will look to pass on these skills and experiences to voluntary sector organisations working with younger children as well as directly to parents.

#### 6.8 Streets Alive

As part of the Outreach Programme, it is recommended that the Council actively supports the Street Alive 'Street Play Programme.' This programme has successfully been implemented in a number of towns and cities, most notably, Bristol and various areas in London. Street Play has successfully helped to extend children's play opportunities as well as promote greater community spirit and encourage residents to work together. Under the Streets Alive Programme, residents apply for occasional temporary road closure orders to 'open up' their streets for children's play. ## 7 Implications

7.1 The tables below set out recommendations for future investment in children's play facilities to the value of £785,000. There is current budget provision of £692,300 within the existing capital programme to fund the recommendations for 2014/15 – 2016/17. A supplementary estimate of £92,700 from Section 106 receipts is therefore required to fully fund the programme.

The recommendations regarding specific site improvements generally relate to existing or proposed Type B and C play areas. With regard to Type 'A' areas, it is apparent that they can quickly lose their appeal and interest even to younger children. Alongside the site specific recommendations therefore, it is also proposed that a rolling programme of investment into the smaller Type 'A' areas be maintained to keep these current and attractive to younger children. Examples of the types of improvements which will be made to these smaller areas will range from painting and ensuring the areas are bright and colourful, to the installation of new natural play equipment suitable for younger children including ground graphics, play panels, educational and interactive games.
