# **Polling District Review and Polling Arrangements 2011**

# 1. Key Points

1.1 This report informs the Committee of the arrangements for the statutory Review of Polling Districts during 2011 and makes some recommendations for a change to the polling place for West Green in advance of the possible referendum on the Alternative Vote and Borough Council elections in May.

### 2. Recommendations

- 1. That the Polling District Review be conducted as set out in paragraph 4 of the report.
- 2. That the polling place for West Green be changed from West Green Primary School to The Charis Centre, West Green Drive, Crawley

# 3 Background

- 3.1 A polling district is a geographical area created by the sub-division of a constituency, ward or County Division into smaller parts. The Representation of the People Act 1983 places a duty on all local authorities to divide their area into polling districts. Under the current scheme each Borough ward forms one polling district, unless voting takes place at more than one polling place, then the ward is divided in to separate polling districts. It is also necessary to create separate polling districts where County and Borough electoral areas are not co-terminus as is the case in Three Bridges and Northgate. A copy of the current scheme is attached at Appendix A.
- 3.2 The Council is required by the Electoral Administration Act 2006 to complete a Review of Polling Districts and Polling Places every four years. The first Review under this legislation was completed in 2007 therefore the Council is required to undertake a Review and implement a new polling scheme in 2011. The scheme has been kept under constant review since 2007 and the Committee has agreed some ongoing changes in the light of experience at elections and changes in circumstances.
- 3.3 The legislation gives some clear guidance on how the Review must be carried out. When designating polling districts the authority must seek to ensure that all electors in the constituency have reasonable facilities for voting, and, as far as practicable that the polling places are accessible to all electors.
- 3.4 When considering the designation of a polling place the authority must have regard to the accessibility needs of disabled people. In addition the authority must seek representations from people or organisations that have expertise in relation to access to premises or facilities for persons who have different disabilities.

### 4 Content

#### **Recommended Approach**

4.1. The legislation states that public notice of the Review must be given and it is proposed that this is done with a notice in the local press, on the Council's website and a direct invitation to make comments to local political parties, disability organisations and ward councillors. The following timetable is suggested using the draft calendar of meetings for 2011/12:

4.2 All existing polling places will be inspected by the Council's Access Officer with the Electoral Services Manager to identify any access issues.

#### 5 Polling arrangements for West Green Ward

- 5.1 Polling in West Green ward has for many years taken place in West Green Primary School. The building adjacent and connected to the school, the Charis Centre (formerly part of the school site) has recently been acquired and refurbished by Crawley Community Church and is available for use as a polling place.
- 5.2 This Charis Centre offers very good, accessible facilities. Polling would take place in the main hall. As the entrance is next to the entrance to the school, potential voter confusion by the change would be avoided. The building is closer to the car park, giving easier access to those with difficulty with walking. The change would also avoid the need to close the school on polling day, which has been the subject of complaints from parents. The school is supportive of the proposed change.
- 5.3 One of the Ward Councillors for West Green has raised a concern about pedestrian safety at the start and end of the school day, in particular that children have to cross over the entrance to the car park that would serve the polling place. To help alleviate these concerns "polling station parking only" signs could be provided at the entrance to the car park from West Green Drive. The car park is shared by the Charis Centre and school staff. The school has agreed that the staff would not use the car park on polling day, and will arrange for their site manager to supervise the entrance and support their crossing patrol at pick up and drop off times
- 5.4 There are no scheduled Borough Council elections in West Green this year, but with the possibility that the Alternative Vote referendum is held, it is recommended that this change take place in advance of the review. The success of the change could then be considered when the Committee undertakes the Review in June.

#### 6 Ward Members' Views

- 6.1 Ward Members will be consulted as part of the Review.
- 6.2 Regarding the proposed change to polling arrangements, Councillor Cumper has raised concerns about traffic safety as outlined in the report. Councillor Crane supports the change and states that polling has taken place in the building that is now the Charis Centre when it was part of the school in the past.

### 7 Staffing, Equalities, Financial and Legal Implications/Powers

- 7.1 The Electoral Administration Act 2006 sets out a duty for the Council to carry out a polling district Review every four year, that representations must be made by the Returning Officer, and that the Council must actively seek representation from persons it thinks have expertise in relation to access to premises or facilities for persons with different forms of disability.
- 7.2 The Council must comply with the review process set out in sections 18A-18E and schedule A1 of the Representation of the People Act 1983.
- 7.3 The Council must publish the comments that it receives in the Review.
- 7.4 An Equality Impact Assessment has been completedy
