20. Members' Disclosure of Interests

No disclosures of interests were made by Members.

21. Minutes

The minutes of the meeting of the Committee held on 20 January 2015 were approved as a correct record and signed by the Chair.

22. Annual Review of the Constitution

The Committee considered report LDS/097 of the Head of Legal and Democratic Services which considered whether any changes were required in 2015/16 to the provisions for Call-In and Urgency. The report also sought approval to disband the Council's Membership Committee.

The Committee supported the disbandment of the Membership Committee and several Committee members suggested that, as a result, the time between the elections and the Full Council AGM could be compressed. It was felt that bringing forward the AGM would be especially useful when there was a change in administration as it would speed up the hand-over of the Council.

The Committee was informed that although officers could provide Group Secretaries and Group Leaders with advance warning of deadlines for membership nominations

and a range of provisional indicative proportionality figures, it would not be possible to issue final proportionality figures until after an election count. It was emphasised that members would need to return their membership nominations promptly to allow for expediency. It was agreed that the possibility of compressing the time between the election and the Full Council AGM be explored.

The Committee considered the changes to the Constitution proposed as a consequence of disbanding the Membership Committee. It was agreed that the following further amendments be made:

- Amend paragraph 1.2(vi) of the Council Procedure Rules as follows: “appoint the ~~Chairmen~~ and Vice-~~Chairmen~~ of the Council’s Committees and Sub-Committees” to be consistent with the term used in the Constitution;
- Delete the following wording from the end of paragraph 24.1(2) of the Council Procedure Rules: “and providing for at least one seat for each political group (except for the Cabinet)” as it was not relevant;
- Amend paragraph 24.2(2) of the Council Procedure Rules as follows: “**With the exception of the Leader**, no member shall be appointed to any of the positions referred to in (1) above so as to hold office later than the next Annual Meeting of the Council” to accord with current procedure.

The Committee noted that reports proposing the disbandment of various working groups/the Policy Development Forums and the Performance Monitoring Scrutiny Panel were due to be considered at the June Cabinet meeting and the March Overview and Scrutiny Commission meeting respectively.

RESOLVED

That the Full Council be recommended:

1. To agree that since the provisions relating to Call-In and Urgency have not been used during the past twelve months, no change to the provisions are necessary at this stage;
2. That the Membership Committee be disbanded;
3. That, as a consequence of the disbanding of the Membership Committee, the changes to the Constitution set out in Appendix 1 to these minutes be agreed.

23. Closure of Meeting

With the business of the Committee concluded, the Chair declared the meeting closed at 7.25pm.

A summary of the replies received shall be circulated to the Membership Committee. The Head of Legal and Democratic Services will also write to the leaders of all political groups asking for their nominations to serve on the Committees and Sub-Committees of the Council, and if appropriate on the Cabinet (including which portfolio they will be responsible), and on any other bodies to which the Council makes nominations.</p> <p>(2) The Head of Legal and Democratic Services Council shall appoint a Membership Committee which shall submit a report to the Annual Council with its the recommendations nominations of the party group leaders to the Council as to the constitution of the several standing Committees and Sub-Committees of the Council, and the Cabinet and on the cycle of meetings of the Council, Committees and Sub-Committees. The Members shall be appointed to the Membership Committee on the nomination of the party group leaders to the Head of Legal and Democratic Services, having regard to the political composition of the Council. and providing for at least one seat for each political group.</p> <p>(3) The Membership Committee shall hold a meeting in May in each year for the purpose of making recommendations in accordance with the provisions of this Council Procedure Rule and Rule 24.8.</p>
