Individual Electoral Registration - Update

Report of the Head of Legal and Democratic Services LDS/105

1. Purpose

This report updates the Committee on electoral registration for the elections on 7 May 2015 and the first annual household canvass under Individual Electoral Registration in advance of the publication of the new register on 1st December 2015.

2. Recommendations

2.1 That the Committee notes the progress made in the transition to Individual Electoral Registration and the steps taken to maximise registration.

3. Reasons for the Recommendations

3.1 To inform the Committee of the registration rates for the General and Borough Council election, and the arrangements for the annual register canvass and publication on 1st December 2015.

4. Background

- 4.1 At its meeting held on 20 January 2015 the Committee received a report following the publication of the first annual electoral following the introduction and the first stage of transition to Individual Electoral Registration. The new system introduced by the Electoral Administration Act 2013 requires that
 - new electors register individually and must have their identity verified, either nationally with data held with the Department of Work and Pensions or locally;
 - existing electors must have their identity verified to retain the ability to have an absent vote and to continue to be registered electors must be verified by December 2015.
- 4.2 The number of registered electors had reduced by 2029 when the annual register was published on 1 December 2014. However, the numbers had recovered by the general election. Each household in the Borough received a letter confirming the names registered and explaining how to register those who were not included. A breakdown, comparing the electorate with previous years is set out in the table below.

4.4 Between February and the election there were over 6000 applications to be added to the register. Most of these were via the national registration site. However, of this

number more than 1400 were already registered. Of the non-duplicate applications 143 electors needed to provide documentary proof to be added to the register.

5. ANNUAL CANVASS 2015

5.1 Preparations for the annual canvass of households is now underway and will start in July. The new system of registration requires that each household must be sent and respond to a Household Enquiry Form. The A3 form, which is prescribed by the legislation, contains the names of those electors that already appear on the register and householders must respond by giving new names and deleting names no longer resident. Each new potential elector listed on the Household Enquiry form will then receive an Invitation to Register. In each case non responses will receive at least 2 reminders and a personal visit.

Unconfirmed electors

5.2 Those existing electors whose identities remain unverified will receive at least 2 further reminders before the publication of the new register on 1 December. The Government are to decide in June whether these names should be deleted from the new register. At present there are 4000 unverified names on the register.

6. Implications

5.1 There are significant additional costs involved in implementing individual registration in staff time, printing, postage and stationery which is being met by government grant.
