7. Meetings of the Licensing Sub Committee: Proposals for 2012/13

Meetings of the Licensing Sub Committees are currently arranged on an ad hoc basis which has often meant that dates are organised which are later found to be unsuitable for either Sub Committee Members, the Applicant or Interested Parties. Consequently it has been necessary on several occasions to re-arrange a Sub Committee meeting which has been very costly in officer time and certainly not ideal for Councillors and other parties.

Under the circumstances, the Chair and Deputy Leader (as Portfolio Holder for the corporate calendar of meetings) has agreed that Licensing Sub Committee dates should be set in advance for the whole of 2012/13. This will enable Councillors to be aware of potential Sub Committee dates, and the dates can be advertised on the website for members of the public.
