#### **4. Hackney Carriage Stands**

The Committee considered report PES/079 of the Head of Planning and Environmental Services. The report sought approval, subject to statutory consultation, for the appointment of 3 new hackney carriage stands in the Borough of Crawley.

The Committee acknowledged that requests had been received from the Hackney Carriage trade to provide additional Taxi Stands within the Borough of Crawley as it was felt that currently there was insufficient space to accommodate the current fleet. Due to the over demand for existing taxi stands there was a detrimental effect on both the drivers of hackney carriage vehicles and other road users during peak times when hackney carriage drivers were queuing to gain position on the stands. New stands would assist in resolving this issue.

The report in setting out the full background to this matter, including the legislative requirements considered, indicated that of the sites discussed with the trade and submitted for consideration to West Sussex County Council as the highway authority, 3 were identified as being suitable, with no objections raised. These were:

- Sussex House (temporary until development of site), plan attached as Appendix A to the report.
- Lloyds Bank, plan attached as Appendix B to the report.
- Queensway, plan attached as Appendix C to the report.

The Police had raised no objections to these proposed stands.

The Committee in indicating its approval of the 3 sites identified, sought and obtained clarification on a number of issues, whilst being advised that the Council were restricted in seeking further options for additional / alternative ranks, as there were very limited spaces available within the town to achieve this. Considerations were ongoing in terms of a future alternative to the temporary Sussex House stand, and in terms of the position of the proposed stand on the Lloyds Bank site, full consideration had been given, as required, with regard to the position of the nearby bus stops. Members also noted that there were no bus stops near to either of the other 2 proposed stands. In response to Members comments regarding the potential for a rank to be located in the Broadway, Officers would take this suggestion forward to the Highways Authority, although it was emphasised that the creation of a rank on that site, if agreed, could potentially be a lengthy process, with an amendment required to traffic regulation orders.

## **RESOLVED**

- (a) That the proposed locations of the 3 new hackney carriage stands as detailed at paragraph 4.4 and in Appendices A, B and C of report PES/079 be approved.
- (b) That the Head of Planning and Environmental Services, or officer acting on her behalf, be authorised to submit a public notice to a local newspaper stating the authority's intention to appoint the stands.
- (c) That in the event of no objections being received within the statutory consultation period, the appointment of the stands as detailed be approved to come into effect on the day after the last day of the consultation period.
- (d) That in the event of any objections being received and not withdrawn, a new report be presented to the Committee for consideration.
