5. Scheduling of Licensing Sub Committee Dates

At its meeting on 7 March 2012 (minute 30 refers), the Licensing Committee agreed that the dates for meetings of the Licensing Sub Committee be set a year in advance. The advance setting of dates was intended to make Councillors aware of potential Sub Committee dates, and also meant that the dates could be advertised on the website for members of the public and responsible authorities such as the Police.

The advance setting of provisional dates was in operation for 2012/13 and continues to be in use for 2013/14, however it has become apparent that only a few of the scheduled dates are being used (2 out of 24 in 2012/13 and 1 out of 7 in 2013/14 to date) and therefore the majority of the scheduled Sub Committee have been cancelled. Although other Licensing Sub Committees have taken place, it has not always been possible to use the scheduled dates due to the tight timeframes in which Sub Committees must legally be heard.

Under the circumstances, the Police have advised the Council that they would not object to provisional dates no longer being set. The Vice-Chair (in the absence of the Chair) and the Cabinet Member for Customer and Corporate Services (as Portfolio Holder for the corporate calendar of meetings) have agreed that the Committee be asked for a steer on whether provisional dates for Licensing Sub Committees should be set for 204/15 and beyond.

The view of the Committee is therefore sought as to whether provisional dates for Licensing Sub Committees should be set for 2014/15 and beyond.
