7 Review of Provisions Relating to Call-In and Urgency

Since the publication of the agenda there has been one more case where an item has been protected from the Call-In Procedure on the grounds of urgency as provided for in Call-In Procedure Rule 8.

In line with the Special Urgency provisions set out in paragraph 16.4 of the Access to Information Procedure Rules within the Constitution, on 10 March 2021 the Cabinet approved the following in relation to the Crawley Town Investment Plan – Draft Heads of Terms:

- a) Authorise the Chief Executive to sign the Crawley Town Deal Heads of Terms.
- b) Delegate authority to the Chief Executive in consultation with the Leader of the Council and the Leader of the Opposition to submit to Government, on behalf of the Council, further details of the plans and budget profiles for the individual projects within the Crawley Town Deal and a plan to address the Heads of Terms key conditions.

This was so the Council could respond to the Government by its set deadline of 24 March 2021.

Due to the circumstances surrounding this Protection from Call-In, and that of the Protection from Call-In identified in the main agenda, it is not deemed necessary to change the provisions at this stage.
