Temporary closure of Horsham Road, West Green, 30th May 2020

NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic Horsham Road, **West Green**, in the Crawley District under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Horsham Road from junction with Spencers Road to junction with Newlands Road at the level crossing.

The temporary closure is scheduled to commence on 30th May 2020 for up to 5 days (It is estimated to be completed on 1st June 2020) and is required for the safety of the public and workforce while **Network Rail** undertakes essential flood defence works - closed from junction with Spencers Road to junction with Newlands Road.
