## PUBLIC NOTICE

### Temporary closure of Exchange Road, Crawley, 10th June 2020

**NOTICE IS HEREBY GIVEN** that from the date specified below, West Sussex County Council has temporarily closed to all traffic Exchange Road, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Exchange Road for a distance approx 71 metres

The temporary closure is scheduled to commence on 10th June 2020 for up to 5 days (It is estimated to be completed on 12th June 2020) and is required for the safety of the public and workforce while GTC - Power on Connections undertakes 24hr Road Closure from the junctions with Northgate Avenue Roundabout to Kilnmead to undertake 2 x road crossing for the installation of substation

The restriction will be in place **24hrs**.

Access for emergency service vehicles and pedestrians will be maintained at all times during the closure.
