<p>3 COVID-19: Test and Trace</p> <p>As of 28 May 2020, anyone who tests positive for Coronavirus will be contacted by NHS Test and Trace and will need to share information about their recent interactions. This could include household members, people with whom they have been in direct contact, or within two metres for more than 15 minutes. People identified as having been in close contact with someone who has a positive test must stay at home for 14 days, even if they do not have symptoms, to stop unknowingly spreading the virus.</p> <p>The Council's Environmental Health Officers are involved with this, working closely with West Sussex County Council's Director of Public Health, and are contributing to the development of an outbreak plan for Crawley and providing resources for local test and trace work.</p>

Temporary closure of Gatwick Road, Crawley, 22nd June 2020

NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic Gatwick Road, Crawley, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Gatwick Road for a distance approx 246 metres

The temporary closure is scheduled to commence on 22nd June 2020 for up to 5 days (It is estimated to be completed on 26th June 2020) and is required for the safety of the public and workforce while Hobart Paving Company undertakes 24hr Bus Lane Closure to undertake the installation of new advanced direction sign.

Temporary closure of A264 Crawley S/western Bypass Westbound, 22nd June 2020

NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic A264 Crawley S/western Bypass Westbound in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on A264 Crawley S/western Bypass Westbound for a distance approx 269 metres

The temporary closure is scheduled to commence on 22nd June 2020 for up to 5 days (It is estimated to be completed on 26th June 2020) and is required for the safety of the public and workforce while **Edburton Contractors** undertakes Westbound Road Closure between the Pease Pottage Roundabout and the Tollgate Hill Roundabout to undertake carriageway surface including replacing high friction surfacing and road marks

The restriction will be in place **overnight only** from 20:00 until 05:00

WEST SUSSEX COUNTY COUNCIL TEMPORARY TRAFFIC REGULATION

HAZELWICK AVENUE FLYOVER, THREE BRIDGES

NOTICE IS hereby given that in pursuance of the provisions of Section 14(2) of the Road Traffic Regulation Act, 1984, as amended, the use of (and parking on) **Hazelwick Avenue Flyover, Three Bridges** from junction with **Northgate Roundabout to junction with Gatwick Road Roundabout** is temporarily prohibited from **17/06/2020 at 09.30 until 17/06/2020 at 15.00**

The restriction will be in place off peak only between 09.30 – 15.00

This closure is necessary to allow **Balfour Beatty to undertake urgent carriageway pothole repairs on behalf of WSCC**

Emergency vehicle, Residential and Pedestrian access will be maintained at all times via the diversion route
