| <p>4      <b>Action Taken Under Delegated Powers (Significant Operational Decision): IT Infrastructure to the Public Cloud</b></p> <p>Report DAT/03 was considered by Cabinet on 25 November 2020 with approval sought for the business case for the migration of IT infrastructure to a public cloud together with delegated authority to the Head of Digital and Transformation for the mobilisation of a project and to sign the necessary contracts to move the IT Infrastructure to the public cloud.</p> <p>Following the delegated authority approval, the Head of Digital and Transformation initiated a procurement exercise and providers submitted a tender response. Assessment was undertaken to choose a provider that was most economically advantageous to the Council. This reviewed price, fit to requirements, delivery, skills and ongoing management support.</p> | 21 - 22 |
