WEST SUSSEX COUNTY COUNCIL TEMPORARY TRAFFIC REGULATION

KELVIN LANE, NORTHGATE

NOTICE IS hereby given that in pursuance of the provisions of Section 14(2) of the Road Traffic Regulation Act, 1984, as amended, the use of (and parking on) **Kelvin Lane, Northgate** from junction with **Faraday Road to junction with Newton Road** is temporarily prohibited from **24/03/2021 at 09.30 until 24/03/2021 at 15.00**

The restriction will be in place off peak only between 09.30 – 15.00

This closure is necessary to allow **Balfour Beatty to undertake urgent carriageway pothole repairs on behalf of WSCC**

Emergency vehicle, Residential and Pedestrian access will be maintained at all times
