Temporary closure of Ifield Drive, Crawley, 16th June 2021

NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic Ifield Drive, Crawley, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Ifield Drive, with works taking place at the junction of Tangmere Road with Ifield Drive.

The temporary closure is scheduled to commence on 16th June 2021 for up to 5 days (It is estimated to be completed on 16th June 2021) and is required for the safety of the public and workforce while Balfour Beatty on behalf of West Sussex County Council undertakes a day time Road Closure for carriageway resufacing. Closed from the junction of Rusper Road to junction of Ifield Drive,

The restriction will be in place day-time only from 08:00 until 17:00

Access for emergency service vehicles and pedestrians will be maintained at all times during the closure.
