Following the success of the autumn 2020 auction, Crawley is again working in partnership with the County Council and other partner authorities in Sussex to help residents install solarpanels and reduce their carbon emissions.

Solar Together Sussex offers high-quality solar panels and battery storage to people across the county. It's a group-buying scheme, which brings Sussex's households together to get high-quality solar panels at a competitive price.

Residents who have already invested in solar panels can opt for 'retrofit' battery storage to get more from the renewable energy they generate and increase their independence from the grid.

From w/c 13 September 2021 5,500 Crawley properties identified as potentially suitable for solar PV will receive a letter inviting them to register for the scheme.

Households will be able to register free of charge for Solar Together Sussex between 23 August and 28 September 2021. The process is as follows:

- Registration the homeowner registers their interest in the scheme for free at <u>www.solartogether.co.uk/crawley</u>. They provide some basic information about their roof, such as size and orientation.
- Auction a supplier 'auction' will be held on 28 September when approved solarinstallers will bid to supply solar panels to all the households who have registeredtheir interest, with the most competitive bid winning. The more people that register, the better the deal should be for each household.
- Personal recommendation from the start of October, those who
 have signed upwill be emailed a personal recommendation and

Action Taken Under Delegated Authority (Significant Operational Decision): Extension of Lease Agreement of the Orchard Building to Crawley Community Action to December 21st 2023

Crawley Community Action (CCA), a voluntary and community sector infrastructure organisation, have a lease agreement (peppercorn rent) in place with the Council for The Orchard, 1-2 Gleneagles Court, Brighton Road, Crawley, West Sussex, RH10 6AD, until December 2021 (a 6 month extension to the current lease agreement, to June 21st 2022, was agreed on 16th June 2021 with a view to further extension based on CCA's future business plan). CCA are seeking an extension to the lease agreement, forming part of their business model to deliver their future programme of work.

On 13 August 2021 the Deputy Chief Executive, in consultation with the Cabinet Member for Public Protection and Community Engagement, took the Significant Operational Decision to agree an 18 month extension to the current lease agreement, to December 21st 2023, based on CCA's business plan.

In signing the lease, CCA agree to:

- Provide ongoing infrastructure support to voluntary and community groups in Crawley.
- Meet with representatives from CBC on a quarterly basis to provide feedback against these outcomes.
- Continue to ensure that existing and new voluntary and community organisations are able to access and use the space at The Orchard making it a hub for the voluntary and community sector in Crawley.

Dear Resident

I'm inviting you and your home to be part of the success story that is Solar Together Sussex.

Since 2019, we have installed solar panel systems in more than 300 households across Sussex. On average, homeowners have saved 33% on installation costs, £300 on their energy bills in year one, and stopped harmful carbon emissions entering the atmosphere.

Solar Together Sussex - buying solar panels and battery storage made easy Installations generally don't need planning permission. However in some cases, such as in Conservation Areas and on listed buildings, planning permission may be required. For planning advice please visit www.crawley.gov.uk/planning/planning-applications

Do you already have solar panels installed? You can also register to have battery storage added to your existing solar panels to maximise the benefits of your system. For more information please see the leaflet accompanying this letter.

How does it work?

- **1. Registration:** you can register before 28 September for free and without obligation at **www.solartogether.co.uk/crawley**. Simply provide details about your roof, such as its size and orientation. The more people that register, the better the deal should be for each household.
- **2. Auction:** on 28 September our approved solar installers will bid for the work in a reverse auction. The most competitive offer from these pre-vetted installers wins the auction.
- **3. Personal recommendation:** from 18 October you will be emailed a personal recommendation for your home, based on the details you provided during registration. This will include the costs and specification for a complete solar panel installation.
- **4. You decide:** the decision is then yours as to whether you want to accept your recommendation. There is no obligation to continue. You will have until 26 November to decide and will be invited to an online information session prior to this end date.
- **5. Installation:** if you accept, the winning installer will contact you to survey your roof and set an installation date. All installations are planned to be completed by the end of May 2022.
