Temporary closure of Creasys Drive, Broadfield, 13th October 2021

NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic Creasys Drive, Broadfield, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Creasys Drive, on the bend of Creasys Drive between Jacksons Road and Eddington Hill.

The temporary closure is scheduled to commence on 13th October 2021 for up to 5 days (It is estimated to be completed on 13th October 2021) and is required for the safety of the public and workforce while West Sussex County Council undertakes Off Peak road closure for Cherry picker to access telecoms mast for testing / mai. Closure point - Coachmans Drive roundabout and Abrahams Road.

Temporary closure of Hazelwick Avenue, Three Bridges, 18th October 2021

NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic Hazelwick Avenue, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Hazelwick Avenue Northbourn carriageway.
