NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic Maidenbower Drive, Maidenbower, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Maidenbower Drive between Laud Drive and St Vincent Close

Temporary closure of Martyrs Avenue, Langley Green, 18th October 2021

NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic Martyrs Avenue, Langley Green, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Martyrs Avenue between London Road and Depot Road

The temporary closure is scheduled to commence on 18th October 2021 for up to 5 days (It is estimated to be completed on 22nd October 2021) and is required for the safety of the public and workforce while UK Power Networks undertakes 24hr West bound Road Closure on Martyrs Avenue between London Road and Depot Road to include a ban on the left turn (west bound) off Martyrs Avenue into Dobson Road. Ban of a left hand turn on to Martyrs Avenue from London Road. Ban of a right hand turn onto Martyrs Avenue off London Road. NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic St Marys Drive, Crawley, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on St Marys Drive, from the railway bridge on St Marys Drive to just before Hazlewick School Close
