#### 5 Action Taken Under Delegated Powers: Calculation of Non-Domestic Rates Income for the Year 2022/2023

On 2 February 2022 Councillor Lamb, Leader of the Council, exercised their delegated authority to approve the Calculation of Non-Domestic Rates Income for the Year 2022/2023 as set out in report FIN/558 published in Information Bulletin IB/1115.

## Action Taken Under Delegated Authority: Amendments to the Crawley Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2009

On 8 February 2022 Councillor Peter Lamb, as Leader of the Council, took an urgent decision as it has not been possible to convene a meeting of the Cabinet in line with the usual required processes, however the urgency and protection from Call-in procedures have been followed.

The Council sought, under its powers contained in the Road Traffic Regulation Act 1984 and all other enabling powers to amend the Crawley Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2009 in accordance with <a href="the Local Authorities">the Local Authorities</a>' Traffic Orders (Procedure) (England and Wales) Regulations 1996 (legislation.gov.uk)

The reason for urgency was that the Kingsgate Car Park element of the Off Street Parking Order was time critical and urgent as the Car Park was not in use and as such had a negative impact on the Council's revenue as no income could be collected. Following this decision to amend the Parking Order to include Kingsgate Car Park it can opened which will ensure the best value for money for the taxpayer.

In relation to this matter the Leader agreed to:

- a) Approve the following amendments (1, 4, 5 & 6) to the Crawley Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2009 as set out in section 4.9 of consideration report HCS/037.
  - To incorporate Kingsgate Car Park into the Parking Order. This car park is an existing car park that was previously run by NCP and has been acquired by the Council.
  - 4) To amend the charging hours at the Town Hall Multi Storey Car Park so that charges are payable between 7am and 12 midnight.
  - 5) To introduce weekend and evening rates at the Town Hall Multi Storey Car Park and Orchard Street Multi Storey Car Park
  - 6) To make administrative changes to the Parking Order including additional methods and means of payment available at all car parks, including Kingsgate
- b) That consideration of proposed amendment 3 (as set to in section 4.9 of the consideration report HCS/037) be referred to a future meeting of the Cabinet.

- c) Reconfirm that the Head of Community Services has delegation to consider the proposed amendment 2 (as set to in section 4.9 of the consideration report HCS/037).
- d) Delegate implementation of the approved Parking Order to the Head of Community Services in consultation with the Head of Legal, Governance and HR and the Cabinet Member for Environmental Services and Sustainability. This will, following the prescribed the legal process, include:
  - Letter to the objectors
  - Letters seeking the agreement of WSCC (include all objections)
  - Seal Order
  - Notice of Making the Order.
  - Notices for Publication within 14 days of making the Order
  - Specify when the Order has effect (signage)

The report (Consideration Report HCS/037 of the Head of Community Services) on which this decision was taken is attached.

The reasons for taking this decision were the recommendations are required to ensure that the operation and enforcement of the Council's portfolio of owned and managed off-street car parks are legally compliant and in place as soon as possible. The recommended approach aims to provide a balance between ensuring a compliant, high quality service which continues to support the wider needs of residents and businesses relating to parking provision, local traffic congestion and mitigate any future potential risks.

Without this in place the Council is unable to charge for parking, nor enforce matters, which will have a significant impact on parking availability and income streams to deliver services and maintain parking areas. The Kingsgate Car Park element in particular is time critical and urgent as not having the Car Park in use has a negative effect on the Council's revenue as no income can be collected. As soon as a decision can be made to amendment the Parking Order to included Kingsgate Car Park it can opened which ensures the best value for money for the taxpayer.

# 7 Action Taken Under Delegated Authority (Significant Operational Decision): Amendments to the Crawley Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2009

A consultation took place on the Crawley Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2009. An increase in the fees to be paid for the relevant car parks (as set out in the consultation) was proposed.

On 9 February 2022 the Head of Community Services approved an increase in fees to be paid for parking as set out in the consultation and the attached table, and that the legal process be followed to implement and include these variations in the Crawley Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2009.

## Amendments to the Crawley Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2009

Report of the Head of Community Services, HCS/37

#### 1. Purpose

1.1 Following a full public consultation on the amendment to the Crawley Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2009, the Leader of the Council is asked to consider the responses received, identify any amendments they wish to make to the proposal and approve in principle the final order.

#### 2. Recommendation

- a) To consider the consultation responses in respect of the proposals as outlined and agree a course of action
- b) Approve amendments 1,3,4,5 & 6 to the Crawley Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2009, as set out in section 4.9.
- c) Amend item 2 of the proposal (section 4.9), specifically delaying the proposed extension to chargeable hours at Tilgate Park and Fisherman's Car Parks.
- Delegate the implementation of the approved order to the Head of Community Services in consultation with the Head of Legal, Governance and HR and appropriate Cabinet Member. This will include;
  - Letter to the objectors
  - Letters seeking the agreement of WSCC (include all objections)
  - Seal Order
  - Notice of Making the Order.
  - Notices for Publication within 14 days of making the Order
  - Specify when the Order has effect (signage)

#### 3. Reasons for the Recommendations

3.1 The recommendations are required to ensure that the operation and enforcement of the Council's portfolio of owned and managed off-street car parks are legally compliant and in place as soon as possible. The recommended approach aims to provide a balance between ensuring a compliant, high quality service which continues to support the wider needs of residents and businesses relating to local traffic congestion and mitigate any future potential risks.

- 3.2 Without this in place the Council is unable to charge for parking, nor enforce matters, which will have a significant impact on parking availability and income streams to deliver services and maintain parking areas.
- 3.3 Elements of this amendment are time critical, specifically those relating to Kingsgate Car Park and Crawley Hospital Car Park.

#### 4. Background

- 4.1 Following the closure of Kingsgate Carpark in 2021 following NCP's termination without notice of the lease agreement, the council voted to approve plans to bring this back under council operational control. In order to do this, legislation requires Crawley Borough Council (CBC) to consult and approve an amendment to the Crawley Borough Council Traffic Regulation Order.
- 4.2 In addition, in November 2021, Cabinet approved the necessary delegations that allow for the negotiation and securement of an agreement with NHS Property Services Ltd for CBC Parking Services to continue the operation and enforcement of the Off Street Parking Order at Crawley Hospital Car Park.
- 4.3 These elements are time critical if we are to meet the agreed deadlines for opening and / or resuming enforcement.
- 4.4 Wider commercialisation and sustainability opportunities also exist in other CBC owned and managed multi-storey and off-street parking facilities including Exchange Road, Orchard Street, Tilgate Park main carpark & Fisherman's carpark. During the pandemic period, parking-related income has seen significant reductions and management of this is critical to ensure we can provide effective and sustainable traffic and road management operation interventions.
- 4.5 Increases in parking charges by way of a variation require public notification and more substantive changes such as the inclusion of "pay to park" areas, such as Kingsgate and/or changes to charging practice require amendments to the Order. Each is subject to either a notification or public consultation process. This report summarises the responses to the notification and consultation.
- 4.6 In order to do this, the Council is required to amend the Off-Street Parking Places Order, and to issue a Notice of Amendment to incorporate proposed changes, following a prescribed consultation process that finished on 26<sup>th</sup> January 2022.
- 4.7 The legal process to update the Off Street Parking Places Order to support the proposed changes is considered in two parts:
  - a. Notice of Amendment: Where the order is being amended to include a new product / restriction / change of wording to the Order that may impact the car park and requires a consultation period of 21 days and a series of other legal interventions to complete the process.
  - b. Notice of Variation of Charges: Where charges are changed in the Order for some or all car parks and requires a 21 day notice period before those charges can be made. There is no requirement to consult. This applies to the proposed increase to pay and display charges.

- 4.8 The Council seeks, under its powers contained in the Road Traffic Regulation Act 1984 and all other enabling powers to amend the Crawley Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2009.
- 4.9 The effect of the amendments will be:-
  - (1) to incorporate Kingsgate Car Park into the order. This car park is an existing car park that was previously run by NCP and has been acquired by the Council.
  - (2) to increase the fees to be paid for parking (as set out in the consultation) at the following car parks: Fisherman's, Orchard Street Surface, Orchard Street Multi Storey, Tilgate and Town Hall Multi Storey.
  - (3) to amend the charging hours at Fisherman's and Tilgate car parks so that charges will be payable between 9am and 6pm throughout the year.
  - (4) to amend the charging hours at the Town Hall Multi Storey Car Park so that charges are payable between 7am and 12 midnight.
  - (5) to introduce weekend and evening rates at the Town Hall Multi Storey Car Park and Orchard Street Multi Storey Car Park
  - (6) to make administrative changes to the order including additional methods and means of payment available at all car parks, namely Fisherman's, Hospital Car Park, Kingsgate, Orchard Street Surface, Orchard Street Multi Storey, Tilgate and Town Hall Multi Storey

#### Notice of Variation of Charges

- 4.10 On 26<sup>th</sup> January 2022, the Council issued a Notice of Variation of Charges and advertised this in local press, via notices in public spaces including in car parks and via social media. This is a statutory process set out in legislation, but which *does not* require public consultation. Where charges are changed in the Order for some or all car parks, the Council is required to provide a 21 day notice period before the change in charges can be made. This applies to the proposed increase to pay and display charges.
- 4.11 As such, it is recommended that item 2 (section 4.5 of this report) is already agreed.

#### Consultation

- 4.12 The Road Traffic Regulation Act 1984 requires the Council to issue a Notice of Amendment where the order is being amended to include a new product / restriction / change of wording to the Order that may impact the car park. The council are also required to undertake a full public consultation for a period of 21 days alongside a series of other legal interventions to complete the process.
- 4.13 The elements which we therefore consulted upon to gain an understanding of the publics views were 1,3,4,5 & 6, as set out in section 4.5 of this report.

#### 5. Key Areas for Consideration

5.1 As part of this process, Crawley Borough Council are not required to carry out consultation in relation to car park fees and charges. The increased fees and charges element has already been approved as part of the Budget Strategy (<u>Budget Strategy 2021/22 - 2025/26 FIN/508</u>) and through decisions taken by Cabinet

Members within delegated authority. Whilst these increases haven't yet been implemented due to service and legal anomalies that this process will resolve, the decision to increase fees & charges has effectively been taken.

- 5.2 Any departure from the agreed budget strategy relating to fees & charges would be a key decision and would require debate and approval at Full Council. Any delay would have a significant financial impact on the service and further delay the opening of Kingsgate Carpark. In addition to the financial impact associated with Kingsgate Carpark, delays would cause disruption to operational viability of other offstreet parking and would put at risk the enforcement contract at Crawley Hospital and which could result in a significant loss of income. This would in turn have a significant impact on the Council's budget position for 2022/23.
- 5.3 There have been strong representations made by both park users and residents local to Tilgate & Fisherman's car park regarding the proposed changes to the chargeable hours at these locations. These responses require further consideration as serious concerns have been raised in relation to displacement of traffic into the locality which may cause road safety and accessibility issues.

#### 6. Information & Analysis Supporting Recommendation

#### Consultation

- 6.1 The Council has received 94 representations via formal means to the proposed changes (Appendix One).
- 6.2 The representations focus on:
  - Objections to the increases in charges
  - Objections to the inclusion of additional hours of charging at Fisherman's and Tilgate Car Parks. (Primarily from local residents and participants of Park Run.)
  - Objections to the levels of charges
- A large amount of responses received, which can be read in full in Appendix 1, are in relation to the uplift in charges across all off-street and multi-storey facilities. Crawley Borough Council are not required to carry out consultation in relation to charges and the uplift is critical in ensuring we can deliver a sustainable and effective enforcement provision. The increased fees and charges element has already been approved as part of the Budget Strategy (Budget Strategy 2021/22 2025/26 FIN/508).
- 6.4 We also received a high volume of responses regarding *the amendment* which includes increasing chargeable hours in Tilgate and Fisherman's carpark (amendment 3, section 4.9). A majority of these responses are in relation to 'Park Run' which takes place in Tilgate Park weekly.
- 6.5 Park Run, whilst providing a positive community impact and benefits to physical and mental wellbeing also causes environmental stress on the soft landscaping of the park and pathways and this is increasing as the event grows bigger. As such, the proposal was to invest income into Tilgate Park to ensure we can sustain the additional use and continue to provide a safe and visually pleasing green space to residents and visitors.

- 6.6 Whilst the responses make reference to the amendments' potential to deter people from attending the event, parking at Park Run venues across the country do charge, including in neighbouring Horsham.
- 6.7 Other responses regarding Tilgate and Fisherman's Carparks are from Tilgate Ward residents and particularly ones who live close to the park. It is these responses that require a further decision to be made as serious concern from the residents has been shared in relation to displacement which may cause road safety and accessibility issues.

#### Options for Consideration

- 6.8 It is not recommended to make any adjustments to amendments 1, 4, 5 & 6.
- 6.8.1 Amendment 1 (section 4.9): The amendment to the Order is key to enable the Council to charge and enforce activities at this location. Significant investment has taken place to enable the car park become a secure 24 hour operation, with fees and charges mirroring Orchard Street Multi Storey Car Park. However, payment will be by APP, Card or Permit only.
- 6.8.2 Amendment 4 (section 4.9):
- 6.8.3 Amendment 5 (section 4.9): This reflects that the Town Hall Car Park will become a secure 24 hour facility from April 2022, and mirrors the fees and charges at Orchard Street Multi Storey Car Park, and seeks to future proof Council Car Parks in terms of the inclusion of evening charges,
- 6.8.4 Amendment 6 (section 4.9): This allows for APP based payments across all car parks. Given the challenges at Kingsgate Car Park, APP and Card payment only is supported. The Council will also operate Permit Parking in the same way it does in its other car parks.
- 6.9 Further to the consultation responses, the following options, specifically related to Item 3 (Tilgate & Fisherman's Car parks), have been considered.

#### 6.10 Option one:

Proceed with proposed amendments to the Crawley Borough Council Traffic Regulation Order to increase chargeable hours and increase in fees & charges (exempt from consultation requirement) in relation to Tilgate Carpark and Fisherman's Carpark. This option will result in a projected additional income of £44,032.68pa; income for this proposal is set to be reinvested into increased enforcement demand, and to contribute to the maintenance and operation of Tilgate Park including Tilgate and Fisherman's carparks.

#### 6.11 Option two:

Delay amendments to the chargeable hours of both Tilgate and Fisherman's Carparks until such time a Controlled Parking Zone (CPZ) can be introduced in residential streets surrounding Tilgate Park to prevent displacement of vehicles. Delaying this amendment will result in a decrease in annual income by an estimated £15,244.46. However, retaining the uplift in fees and charges will still result in a projected additional annual income of £28,788.22.

#### 6.12 Option three:

Delay amendments to the chargeable hours of both Tilgate and Fisherman's Carparks *and* uplift in the fees and charges until such time a Controlled Parking Zone (CPZ) can be introduced in residential streets surrounding Tilgate Park to prevent displacement of vehicles. This will result in no additional income associated with Tilgate & Fisherman's carpark, and will impact on maintenance of Tilgate Park.

#### Recommended option

- 6.13 Option two is the recommended option following a full public consultation on proposed amendments to the Crawley Borough Council Traffic Regulation Order. Residents in street surrounding Tilgate Park have expressed concerns around displaced parking as a result of an increase in charging hours and that there are concerns relating to road safety and emergency services vehicles accessing streets particularly at weekends.
- 6.14 This issue is evidenced by the temporary closure of Tilgate and Fisherman's carpark during coronavirus restrictions and there was significant traffic displacement in surrounding streets which caused nuisance and annoyance to residents and posed road safety risks. Residents have highlighted these concerns as part of the consultation and as such, the decision maker is asked to take this into consideration.
- 6.15 As such, the decision is not to permanently exclude Tilgate and Fisherman's carpark from the Traffic Regulation Order, but to delay this until such time Crawley Borough Council can work with West Sussex County Council to mitigate this risk and to ensure that this does not cause displacement of impact negatively on road safety or accessibility.
- 6.16 A number of representations were received in relation to 'Park Run', a weekly running event that takes places within Tilgate Park. Whilst there is recognition of the health and wellbeing benefits of this event, this event has an environmental impact; particularly on the soft landscape adjacent to paths used by runners and, as the event grows in size and popularity, repair and maintenance of these areas are essential for the safety of park users and for positive visual aesthetics.
- 6.17 An increase in fees and charges as planned will provide an income of £15,244.46 which will provide some contribution to the park to ensure maintenance can be up kept.
- 6.18 Initial proposals have already been submitted to West Sussex County Council regarding the introduction of a controlled parking zone in streets surrounding Tilgate Park and should this be the decision taken, Crawley Borough Council will request this proposal is prioritised and any work to introduce be accelerated.

#### Rationale for disregarding other options

6.19 Option one was proposed to ensure Crawley Borough Council can fund the increased enforcement capacity required to deliver an enhanced level of traffic regulation enforcement activity and improve road safety and to reduce nuisance parking on surrounding residential streets. In addition, further funding is required to ensure essential maintenance of Tilgate Park and the extending of chargeable hours was identified as a mechanism to commercialise the park to achieve a more sustainable position. An estimated income of £44,032.68 per annum was projected by introducing an uplift in charges and chargeable hours.

- 6.20 Option three will have negative financial implications of an estimated £44,032.68 shortfall in projected annual income which forms part of existing plans to fund increased enforcement activity and essential park maintenance and to support the park to become more sustainable. Charges are excluded from public consultation requirements and would not be considered as formal feedback to an amendment of a traffic regulation order.
- 6.21 Delegation of implementation of the approved order to the Head of Community Services in consultation with the Head of Legal, Governance and HR and appropriate Cabinet Member will allow for a rapid resolution of the issue.

#### 7. Implications

- 7.1 Financial Implications: The Council is reliant on parking income to achieve a balanced budget. Failure to resolve this matter in a timely way will compromise this significantly.
- 7.2 Failure to respond to legal advice and update the agreement to comply fully with the Road Traffic Regulation Act 1984 could expose the Council to risk of challenge to the issuing of Penalty Charge Notices. The Council has a moral obligation to respond where non-compliance has been formally highlighted.
- 7.3 The proposed approach will seek to retain the positive revenue position for the Council.
- 7.4 Legal and Procurement Implications:

The Council must act in a legal and proportionate way in the enforcement activities afforded to it under legislation. Legal advice has been obtained in relation to how the Council can comply with the legislation and provide relief from congestion in the area by operating its portfolio of off-street car parks. The proposed arrangements and agreements will be finalised having first obtained legal advice.

Councillor	As the County Councillor for Tilgate, I know only too well the issues on nearby roads caused by displacement parking from the park.  While thankfully the number of days each year that the carparks are full are not too many, what is more common is people calculating that the cost of the carparks makes it worthwhile for them to park on the residential roads to avoid the charges, often causing parking difficulties for these residents. A 9% increase this year will only make this worse.  The removal of the free parking before 11am in the Fisherman's carpark will disproportionally impact local people going for relatively short morning walks and runs around the lake in particular - a healthy activity we are all keen to support. It will impact far less on people going to the park for longer visits, often from further afield.  I therefore object to these proposals.	Tilgate and Fishermans
Public SH	I would be very concerned that any increase in parking rates would impact on the number of people using Crawley Town Centre and its associated shops etc. We have already lost Debenhams and multiple other shops in the recent past and anything that can be done to reduce parking costs and motivate people to go into town and not shop online should be explored. Public XX	I am contacting you to object to the proposed changes to the payment hours at the Fishermans Car Park, Tilgate.	Fishermans and Tilgate
	I have 2 reasons for objecting.	
	Firstly, the proposed extension of charging hours at both ends of the day will significantly increase the amount of cars trying to find alternative parking in the local area. Parking spaces for residents are already at a premium and the addition of more vehicles trying to park in residential roads will add to the congestion already well documented in the area. Larger events such as Park Run will obviously cause a huge displacement of cars as the Fishermans Car Park is always very busy during this event and the adjoining car parks at Tilgate Golf Centre, which are at this time free to park in, will be unable to absorb the extra vehicles. This will be particularly noticeable once the weather improves and more golfers are out at earlier times. Residents already suffer on a daily basis with parking problems and to add to this further seems grossly unfair. #### The West Sussex Electric Vehicle Chargepoint Network

Working in partnership, West Sussex County Council, Adur and Worthing District Councils, Arun District Council, Crawley Borough Council, Horsham District Council and Mid Sussex District Council jointly tendered for a supplier partner to work with them to deliver a West Sussex chargepoint network to provide a consistent, affordable, easy to use, reliable, widely accessible and recognisable charging network, providing renewable energy charging, the priority being to provide residents without access to off-road parking with a viable charging solution to assist with the switch to EVs.

In November 2021 a 15 year 100% concession contract was signed to install a countywide chargepoint network with Connected Kerb, a UK based EV charging specialist with experience of working with other local authorities and public sector organisations.

Connected Kerb will be responsible for funding, installing, marketing and operating a network of both fast and rapid chargepoints, providing the West Sussex partners with a low risk solution and protection when technology moves on and a chargepoint becomes obsolete. Although a final decision regarding any site's viability remains with Connected Kerb, by taking a portfolio approach, with more profitable chargepoints supporting less or unprofitable ones, we hope chargepoints will be installed where they are needed.

In the long term chargepoints will be found on street, in public sector car parks, and on community assets, county wide with the first phase of installations taking place in council owned public car parks.

Members will be kept informed of progress and a more detailed project timetable, and details of the numbers and locations of chargepoints will be made available as soon as possible.

The partnership has established a new brand for the chargepoint network and have launched a new website with information that will be added to and developed over time.

To help develop a network plan we want to know where West Sussex residents would like chargepoints to be. To capture this information, there is an online form on the <u>West Sussex</u>





Although we cannot guarantee a chargepoint will be installed in a location suggested, as it is dependent on a number of factors, it will help us understand demand across the county and will provide valuable insight during network planning and delivery.

The contract is structured so that community landowners can offer their land to be part of the Chargepoint Network. The West Sussex Chargepoint Network website will be updated with specific information for these stakeholders, and a registration form will be added to the site for them to suggest land under their ownership.

### Helping West Sussex residents tackle fuel **DOVERTY** - Advice for Councillors Winter 2022

The need for home energy support services and schemes is emerging as a consistent priority for the Winter of 2022 and is expected to continue. Energy price rises, rising costs of living and the effects of the pandemic are just some of the factors fuelling this crisis. This document gives a brief overview of the home energy support services, eligibility, and contact/referral details for West Sussex residents.

Living in a cold home can cause physical and mental health problems, make existing illness worse, deepen poverty and debt, affect children's education, and increase social isolation. But there are solutions, some words from a trusted professional and/or a Councillor can make all the difference to a vulnerable household, or a household needing to access assistance for the first time.

West Sussex has a range of support services available, including practical advice and grant funding for residents who may be struggling to keep warm and well. West Sussex is part of a consortium of Local Authorities who have been successful in securing Local Authority Delivery (LAD) funding for a range of low carbon heating technologies and insulation measures for low-income households. Updates on these schemes will be found on the West Sussex energy website (listed on the page below), further updates expected in February/March.

#### Action in West Sussex

The West Sussex Affordable Energy Partnership are committed to addressing and reducing the impact and incidence of fuel poverty across West Sussex. The partnership includes representatives from all West Sussex Local Authorities, WSCC and wider community partners. These meetings are quarterly and facilitated by the West Sussex Fuel Poverty Coordinator.



West Sussex The partnership has recently launched: Fuel Poverty: Affordable Energy West Sussex Framework for Action 2021-2026

The purpose of the framework is to bring West Sussex in line with NICE guidance (NG6), England's fuel poverty target<sup>1</sup>, Sustainable warmth: protecting vulnerable households in England policy paper, promote best practice and engage policy makers in the wider conversations about impacts of fuel poverty across West Sussex. We look at current need and demands for services as well as the Governments direction for energy efficiency measures and low carbon technologies. As we look to the future, it is important that we have a fair and just low carbon heating transition for low incomes households.

#### 3. LEAP

This is a winter only scheme – and can become over subsribed, and as such may have to close for new referrals.
