#### Temporary closure of Beehive Ring Road, Crawley, 25th July 2022

**NOTICE IS HEREBY GIVEN** that from the date specified below, West Sussex County Council has temporarily closed to all traffic Beehive Ring Road, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Beehive Ring Road for a distance approx 111 metres
