NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic Woodmans Hill, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Woodmans Hill for a distance approx 102 metres

The temporary closure is scheduled to commence on 24th October 2022 for up to 5 days (It is estimated to be completed on 26th October 2022) and is required for the safety of the public and workforce while BT undertakes Road Closure from the junctions with Woodmans Hill Roundabout to Vulcan Close with works taking place opposite Broadford Junior School to allow BT access to underground sructure for a new customer connection

The restriction will be in place off peak only from 09:30 until 15:30
