Temporary closure of Winfield Way, Crawley, 20th March 2023.

**NOTICE IS HEREBY GIVEN** that from the date specified below, West Sussex County Council has temporarily closed to all traffic, Winfield Way, Crawley, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Winfield Way for a distance approx 47 metres.

The temporary closure is scheduled to commence on 20th March 2023 for up to 5 days (it is estimated to be completed on 20th March 2023) and is required for the safety of the public and workforce while West Sussex County Council undertakes a Road Closure of the bus only section of Winfield Way, to enable Telent to install a new bus bollard.
