Temporary closure of Friary Way, Crawley, 30th June 2023.

NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic, Friary Way, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Friary Way outside of number 58.

The temporary closure is scheduled to commence on 30th June 2023 for up to 5 days (it is estimated to be completed on 30th June 2023) and is required for the safety of the public and workforce while Thames Water undertakes a Southbound Road Closure for the repair of a frame and cover. Road to be closed from the Haslett Avenue West Roundabout to the junction with Station Way..

The restriction will be in place night-time only from 21:00 to 05:00
