Temporary closure of Balcombe Road, Pound Hill, 9th November 2023.

NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic, Balcombe Road, Unknown, in the Crawley District (B) under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Balcombe Road for a distance approx 399 metres.

The temporary closure is scheduled to commence on 9th November 2023 for up to 5 days (it is estimated to be completed on 10th November 2023) and is required for the safety of the public and workforce while West Sussex County Council undertake carriageway patching. Road will be closed between roundabout with Maidenbower Drive and junction with Worth Road.

The restriction will be in place overnight only from 20:00 until 06:00
