5 Action Taken Under Delegated Authority (Significant Operational Decision): Re-allocation of the Community Grants Budget

Due to an increased number of applications received to the small grants scheme, on 6 November 2023 the Head of Community Services agreed to re-allocate £10,000 from the Strategic Grants Budget to the Small Grants Budget allocation.

Both the Cabinet Member for Community Engagement and Culture and the Leader have been consulted and are in agreement with the re-allocation.

6 Review of the Council's Licensing Policy Statement

Crawley Borough Council is reviewing its policy on how it regulates alcohol, regulated entertainment, and late-night refreshment in the borough of Crawley.

Our existing policy was published in March 2019, and remains in place for five years. As required by the Licensing Act 2003, the Council is reviewing the Statement of Licensing Policy to ensure that it remains current and responsive to change.

The Council as Licensing Authority must prepare a Statement of Licensing Policy under the Licensing Act 2003. This Policy Statement sets out the Council's general approach on how it will determine licensing matters, including applications, and how it will carry out its regulatory functions in relation to the sale of alcohol, provision of regulated entertainment, and late-night refreshment in Crawley.

The Council looks to consider all applications on their own merit but also to ensure that operators are complying with the Licensing Act 2003 and primarily upholding the Licensing Objectives. The Policy has regard to the Section 182 Guidance as part of the Licensing Act 2003, balancing the potential risks associated with licensed premises and licensable activities, whilst supporting well run premises and a prosperous economy. The Licensing Policy Statement looks to provide transparency and consistency in the decision making process and is designed to be accessible to anyone with an interest in licensing.

The Council is now consulting on these changes and would really like to hear your views.

The draft Statement of Licensing Policy (2024-2029) can be viewed at the Council's Consultation web page at <u>crawley.gov.uk/consultation</u>. This consultation will run until **midnight on Friday 20 December**.

What happens next?

After the consultation closes, the Council as Licensing Authority will consider your responses, any other relevant information and decide on whether to make any changes to the proposed draft Licensing Policy Statement. It will be reviewed at the Licensing Committee and ultimately considered by Full Council for adoption. The new Statement of Licensing Policy will be published early in 2024.
