NOTICE IS HEREBY GIVEN that from the date specified below, West Sussex County Council has temporarily closed to all traffic, Old Brighton Road, Langley Green, in the Crawley CP under Section 14(2) of the Road Traffic Regulation Act 1984, as amended, on Old Brighton Road for a distance approx 20 metres

The temporary closure is scheduled to commence on 11th December 2023 for up to 5 days (it is estimated to be completed on 12th December 2023) and is required for the safety of the public and workforce while Hutchinson 3G UK LTD undertake an overnight ban of right turn into the access to warehouses and Munch Box, to detect and locate fault in telecoms equipment..
