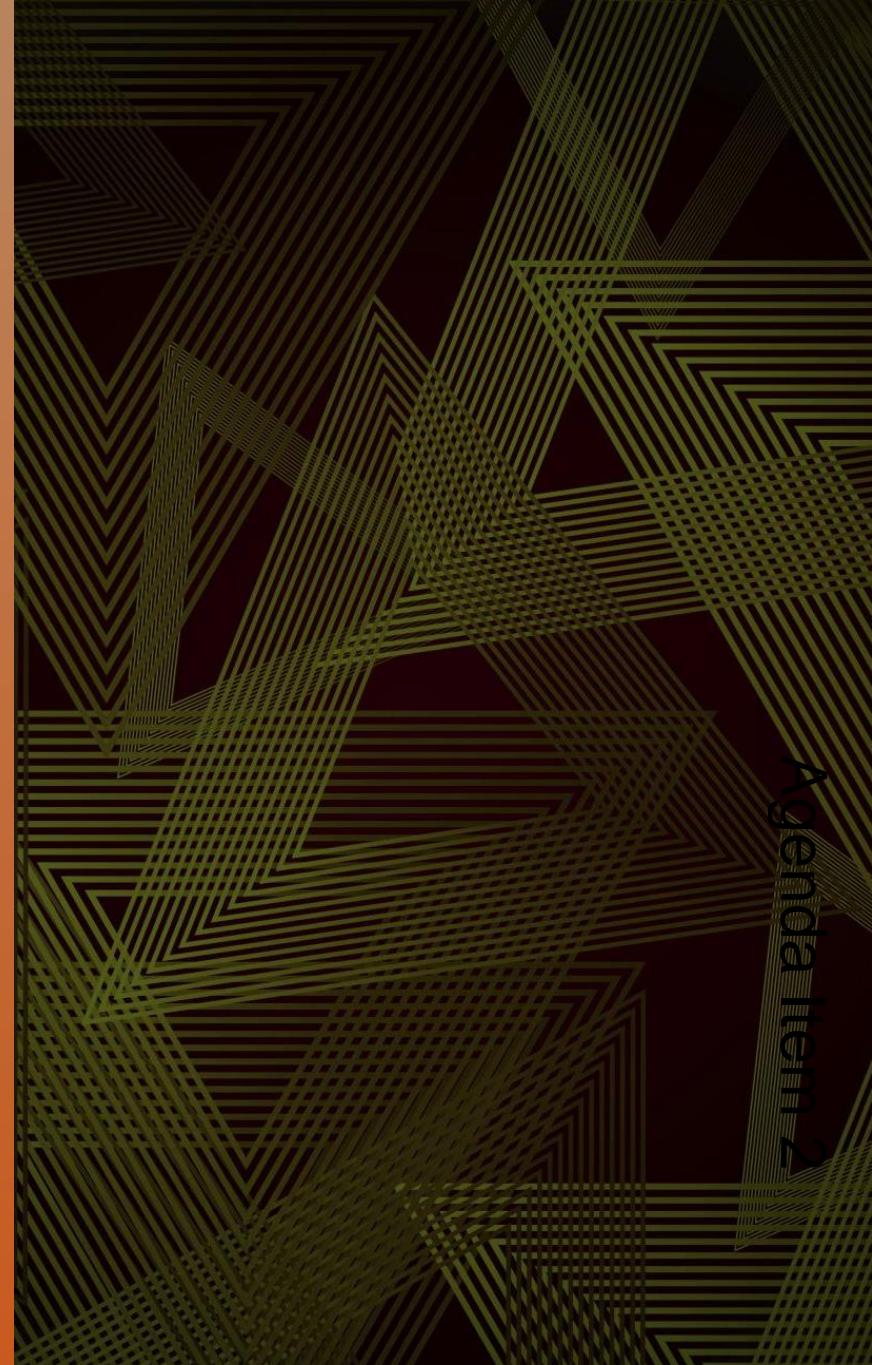

ELECTIONS ACT 2022: TRANCHE 2 (UPDATE)



ONLINE ABSENT VOTING

- 31 October 2023 – Online Absent Voting went live
- All applications now must include the electors National Insurance Number except for an Emergency Proxy
- Every application must be sent to the DWVP via the online portal for a data match
- If they match the application is then processed by the Elections Team
- If they do not match the elector must provide documentary evidence. E.g. a copy of their passport. Once evidence is seen the application can then be processed.
- If any old applications are received the application must be rejected

PAPER APPLICATIONS

- Paper applications can still be accepted as long as they contain all the details
- The Election Team must input them onto portal so they can be sent up to the DWP

MAXIMUM PERIOD

- From 31 October a postal vote can be in place for:
 - A particular poll
 - A definite period of not more than 3 years
 - A maximum period of up to 3 years
- All postal votes will expire on the third 31 January following the date on which their application was accepted.

TRANSITIONAL ARRANGEMENTS

- Any postal vote prior to the 31 October will continue until 31 January 2026
- All those that was due to have a signature refresh next year will still receive a new application however if they do not respond they will not be deleted until 31 January 2026

WHAT THIS MEANS AT ELECTION TIME!

- We request that when parties send out postal vote applications that they encourage voters to apply online rather than complete the paper version.
- If an application is not matched by the DWP the elector has up to 10pm on Election Day to provide their evidence.

PROXY RESTRICTIONS

- As before a proxy must be registered to vote in the election
- A proxy may only act as a proxy for 4 electors
- Of which no more than 2 electors can be domestic electors
- All current proxy application will expire on 31 January 2024
- A notice will be sent out in December
- Currently we have 25 proxies in Crawley
- 14 of those are for Overseas & Crown Servant Voters
- Proxies will have to renew every 5 years

HANDING IN POSTAL VOTE PACKS

- Legislation is due to be made in December
- Candidates, Agents, Election Campaigners or Political Parties are unable to hand in any completed postal packs except for their own or that of a close family member
- Only voters, a family member or a designated carer will be able to hand in a postal vote
- Voters can only hand in five postal packs (in addition to their own)
- Declaration will need to be made by the person handing in the packs
- If declaration is not completed or completed incorrectly postal vote will be rejected

OVERSEAS VOTERS

- Secondary legislation expected to be made and come into effect in January
- Removes the 15-year limit on voting rights for British citizens abroad
- Extends the overseas franchise to all British citizens who have been previously registered or resident in the UK
- Registration will last for up to 3 years – the 3rd 1st November following the day of the application was submitted

BALLOT SECRECY ACT 2023: “FAMILY VOTING”

- Comes into force 2 May 2024
- Offence for a person to be with or near another person at a polling booth, with the intention of influencing them
