<p>3 Action Taken Under Delegated Authority (Significant Operational Decision): Station Gateway (Phase 1) - Final Designs and Planning Application</p> <p>The Station Gateway (Phase 1) project is a significant public realm and bus station improvement scheme at an important transportation hub and principal gateway to Crawley Town Centre.</p> <p>On 29 November 2023, the Cabinet delegated authority to approve the final designs for Station Gateway (Phase 1) to the Head of Major Projects and Commercial Services, in consultation with the Head of Economy and Planning (resolutions (c) of report PES/443).
