LOCAL DISCRETIONARY RATE RELIEF SCHEME

Agree administration, principles and criteria of the distribution of Government grant to local businesses that have seen business rates bills increased as a result of the national revaluation.

In the Government Budget on 8 March 2017, the Chancellor announced £300m of extra funding for local authorities to provide discretionary relief to those business facing increases in their business rates bills following the revaluation. The Government have described this initiative as 'revaluation support'.

Local authorities have the power to design their own discretionary business rates relief schemes to determine how this 'revaluation support' is distributed across businesses locally. The Government has placed a condition that extra relief can only be targeted at businesses that have seen their rates bills increased in April as a result of the revaluation after all other adjustments (e.g. other relief schemes) have been applied, this includes small business rates relief.

BUSINESS RATES RETENTION – 100% BUSINESS RATES PILOT APPLICATION

DCLG have published a paper on 1st September 2017 inviting local authorities to submit pilot bids for one year (2018/19) for 100% localisation of business rates. Bids must be submitted by 27th October 2017, with the outcome being advised by DCLG in December 2017.

100% pilots will retain all locally-collected business rates and will receive additional responsibilities in return. Any difference between the increase in business rate retention and new responsibilities will be offset by an adjustment to top-ups or tariffs. The creation of the pilots will therefore be “fiscally neutral” at baseline. However authorities will gain from retaining 100% of any above-baseline growth.

The Chief Executive has agreed that this will be treated as an urgent item due to work not concluding with all potential West Sussex pooling local authorities until mid-October and will be protected from Call-in.

BROWNFIELD LAND REGISTER

The Housing and Planning Act 2016 introduced a new requirement on Local Planning Authorities to prepare and publish a Brownfield Land Register. This Act also introduced the mechanism for the granting of Permission in Principle, as an alternative route to full planning permission, sitting alongside the established paths of outline, full permission and development order. One form of granting Permission in Principle (and, to date, the only one enacted) is through the site's inclusion in Part 2 of the Brownfield Land Register.

The Brownfield Land Register is to be prepared by the council, and first published by 31 December 2017, and updated annually thereafter. It should provide information for developers and communities about brownfield land suitable for housing. It applies to all brownfield land suitable for housing or housing-led development.

MEMORIAL GARDENS PLAY AREA

To propose the redevelopment, together with agreeing the supplementary budget, rejuvenation and possibly reconfiguration of the play area in Memorial Gardens. The current play equipment and safer surfacing is coming to the end of its life. This is the only free-to-access play area for families visiting the town centre, is currently popular and has potential to be an amenity that helps encourage footfall from families in the centre of Crawley. The play area is a resource for all families across the Borough as well as attracting families from the surrounding towns.

The proposal will recommend the designs include accessible and specialist play equipment (for example, a wheelchair swing) so that children of all abilities are able to use the site. And for designs to be as sympathetic as possible to the surroundings.

Memorial Gardens' play area is currently listed for maintenance only in the approved Report to Cabinet: 'Play Facilities – Investment Proposals' (4 December 2013). However, with the redevelopment of much of the town centre, including Queensway and improvements to visibility in Memorial Gardens, there is an opportunity to upgrade the play area alongside these works.
