Applies to all hirings except those mentioned in tariffs 2, 3 and 4
Initial distance not exceeding 183 metres ( 200 yards) or 61 seconds or un-
completed part thereof
For the next 1426 metres ( 1560 yards) or 479 seconds ( 7 minutes and 39
seconds) or un-completed part thereof
For each subsequent 134 metres ( 147 yards) or 45 seconds or un-completed
20p part thereof

## Tariff 2

Applies to all hirings begun between midnight and 06:00 including all Bank Holidays, and all hirings from 18:00 to 23:59 hrs. on the 24 ${ }^{\text {th }}$ December and from 18:00 on New Year's Eve to 23:59 on $1^{\text {st }}$ January, except any hirings under Tariff 4
Initial distance not exceeding 183 metres ( 200 yards) or 54 seconds or uncompleted part thereof
For the next 1426 metres ( 1560 yards) or 423 seconds (7 minutes 3 seconds) 30p or un-completed part thereof
For each subsequent 152 metres ( 166 yards) or 45 seconds or un-completed
30p part thereof

## Tariff 3

Applies to all hirings all day on 25 and 26 December
Initial distance not exceeding 183 metres ( 200 yards) or 52 seconds or un-
£8.00 completed part thereof
For the next 1426 metres ( 1560 yards) or 409 seconds ( 6 minutes 49 seconds) 40p or un-completed part thereof
For each subsequent 154 metres (168 yards) or 44 seconds or un-completed 40 p part thereof

## Tariff 4

Applies to all hirings between 06:00am and 23:59 where there are 5 or more passengers in the vehicle except on 25 and 26 December (when Tariff 3 will apply)
Initial distance not exceeding 183 metres ( 200 yards) or 61 seconds or un30p completed part thereof
For the next 1426 metres ( 1560 yards) or 479 seconds ( 7 minutes 39 seconds)
For each subsequent 134 metres ( 147 yards) or 45 seconds or un-completed part thereof.

## Extra Charges

A soilage charge of $£ 75$ (maximum)
Where a Hackney Carriage is hired by distance the proprietor or driver shall not be entitled to demand and take a fare greater than that recorded on the face of the taximeter, save for any extra charges authorized by the above table which may not be recorded on the face of such meter. The driver may charge any 'road charge or tolls' where applicable (this must be agreed with the customer before hire commences).
